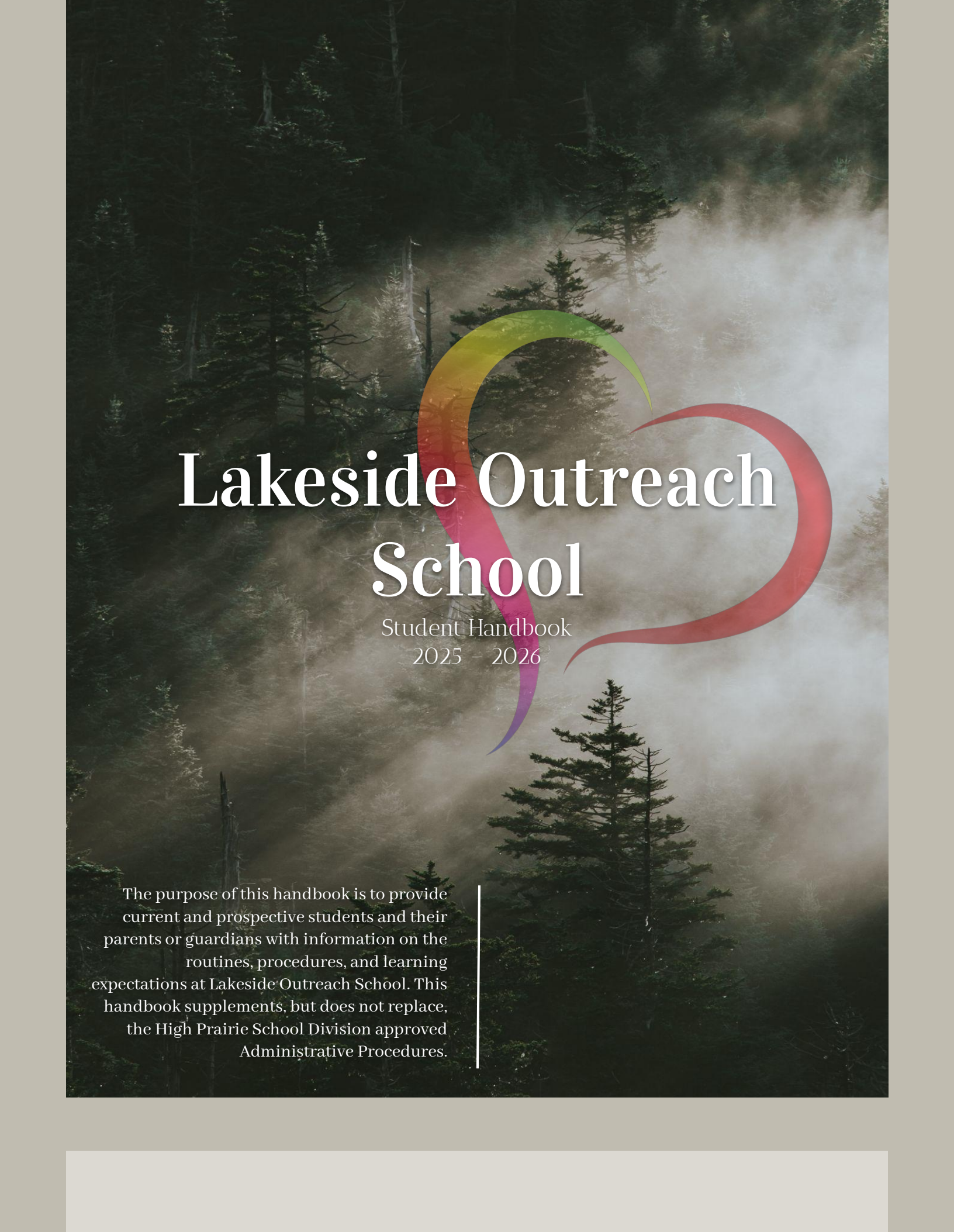




Lakeside Outreach School

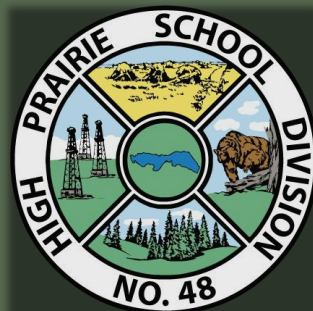

SCHOOL BACKGROUND

Lakeside Outreach School is located in the town of Slave Lake, within northern Alberta's municipal district of Lesser Slave River, approximately 257 km north of Edmonton, on the southeast shore of Lesser Slave Lake and the junction of Highway 2 and Highway 88. The school offers an alternative learning environment to high school students, with flexible programming they are able to independently work through, in-person or at a distance. A dedicated team at Lakeside Outreach School, including teachers, learning support, a career coaches, wellness coach and Indigenous education coach, seek to assist students in achieving their academic goals, while also preparing them to be socially responsible and to succeed locally and globally.

ENROLLING AT LAKESIDE OUTREACH SCHOOL

High school students who meet the following requirements are eligible to enroll at Lakeside Outreach School:

- Student has the legal right to education in the province of Alberta.
- Students are under nineteen years of age on September 1 of the current school year.
- Students are working towards a high school diploma.

Registration Process

NEW STUDENTS

New high school students in the region, who meet enrollment eligibility and are interested in a flexible

and independent learning environment, may apply to Lakeside Outreach School by contacting the school during their regular hours of operation to schedule an interview.

Students will be enrolled through an interview process, to determine if the school environment and learning expectations at Lakeside Outreach School are in the best interest of the student, and whether course requests are currently available. The student and their parent/guardian, if the student is under the age of eighteen, will be required to meet with an administrator or career coach to develop an academic plan the school is able to support. A birth certificate must also be provided before a student is placed in classes.

ENROLLING AT LAKESIDE OUTREACH SCHOOL

CURRENT HIGH PRAIRIE SCHOOL DIVISION STUDENTS

Students attending other High Prairie School Division schools may seek to transfer or enroll in a blended learning program, through a partnership with Lakeside Outreach School, for a variety of reasons. To begin this process, students or parents/guardians must contact their current school's career coach, who can advise the student on availability of courses at Lakeside Outreach School, and how this option might successfully fit into their academic plan. If it is determined to be a feasible option, the career coach will complete a 'Student Transfer Application.'

A committee will review the 'Student Transfer Application' within five school days. The secretary at Lakeside Outreach School will contact the student and/or family directly to register once approved.

Blended students are expected to attend and/or complete coursework during designated blocks and are not to be on-site during times when they are registered in classes at another High Prairie School Division school.

TEACHING & LEARNING EXPECTATIONS



COURSE DELIVERY

Most courses are delivered via Google Classroom, and require students to independently work through a flexible and self-paced educational program. Students are responsible for viewing all course materials, assigned texts and conducting their own research in order to successfully complete teacher-developed summative assessments linked to Alberta Education's Programs of Study. On-campus teacher support is available daily at Lakeside Outreach School, and distance learning students can also schedule phone calls and virtual meetings with their teachers, as needed.

CAREER & LIFE MANAGEMENT (CALM)

CALM is a required course for graduation that is delivered during the second semester, via a seven day 'blitz' that requires students to attend for full days, in-person. Local experts with knowledge around personal, resource and career choices are invited into the classroom to speak to students throughout the seven days, culminating in a field trip to various local businesses to learn about career pathways in the area. This year, CALM is scheduled to take place from March 13-21, 2025.

FOODS

Students at Lakeside Outreach School have two options available in order to earn Foods credits:

1. Students can access learning tasks through the Foods teacher, to be completed independently and submitted, along with video and photo evidence of the preparatory work, process and final product.
2. Students can sign-up for in-person cooking classes to earn Foods credits.

PHYSICAL EDUCATION

Students at Lakeside Outreach School have access to in an in-person, community supported physical education program, that takes place at various local venues daily, from 12:30pm to 1:45pm. On Mondays and Wednesdays Slave Lake's Multi-Rec Centre typically hosts the physical education class, while the Tuesday and Thursday venue varies by month.

ASSESSMENT & REPORTING

Teacher assessment practices are guided by [Alberta Education's Teaching Quality Standard](#), [High Prairie School Division's Administrative Procedure 360 - Curriculum Planning, Assessment And Reporting](#), and High Prairie School Division's Handbook of Fair Assessment and Reporting Practices. Lakeside Outreach School teachers value the importance of varied and quality assessments, and the need to take into consideration observation, conversation and product data to most accurately determine final grades.

UNIVERSAL LITERACY ASSESSMENTS

At the beginning of both school semesters, students enrolled in English Language Arts courses at Lakeside Outreach School will be expected to complete two literacy assessments, from which the data is used to identify learning needs and enhance instructional support. These include the Highest Level of Achievement Test (HLAT) and Reading Comprehension Assessment Tool (RCAT).

HLAT - Writing assessment completed at the beginning and end of a student's English Language Arts course.

RCAT - Reading comprehension assessment completed at the beginning and end of a student's English Language Arts course.



Diploma Exams

Students enrolled in diploma courses at Lakeside Outreach School will typically write their diploma exams at Roland Michener Secondary School at the end of the semester in which they finish their coursework, and as per [Alberta Education's Diploma Exam Schedule](#).

As of September 1, 2023, diploma exams will be weighted at 30% of a student's final mark. 70% of the final mark comes from their coursework. To pass a diploma exam course, students must earn a final combined mark of at least 50%. Students are able to access their diploma exam marks on [myPass](#) approximately three weeks after writing diploma exams.

REPORTING

Lakeside Outreach School teachers are committed to ensuring students receive timely feedback on coursework and that digital markbooks are updated every ten school days. In addition to quarterly report cards being emailed home, students and parents/guardians are able to track student progress regularly by accessing digital markbooks through the family portal online.

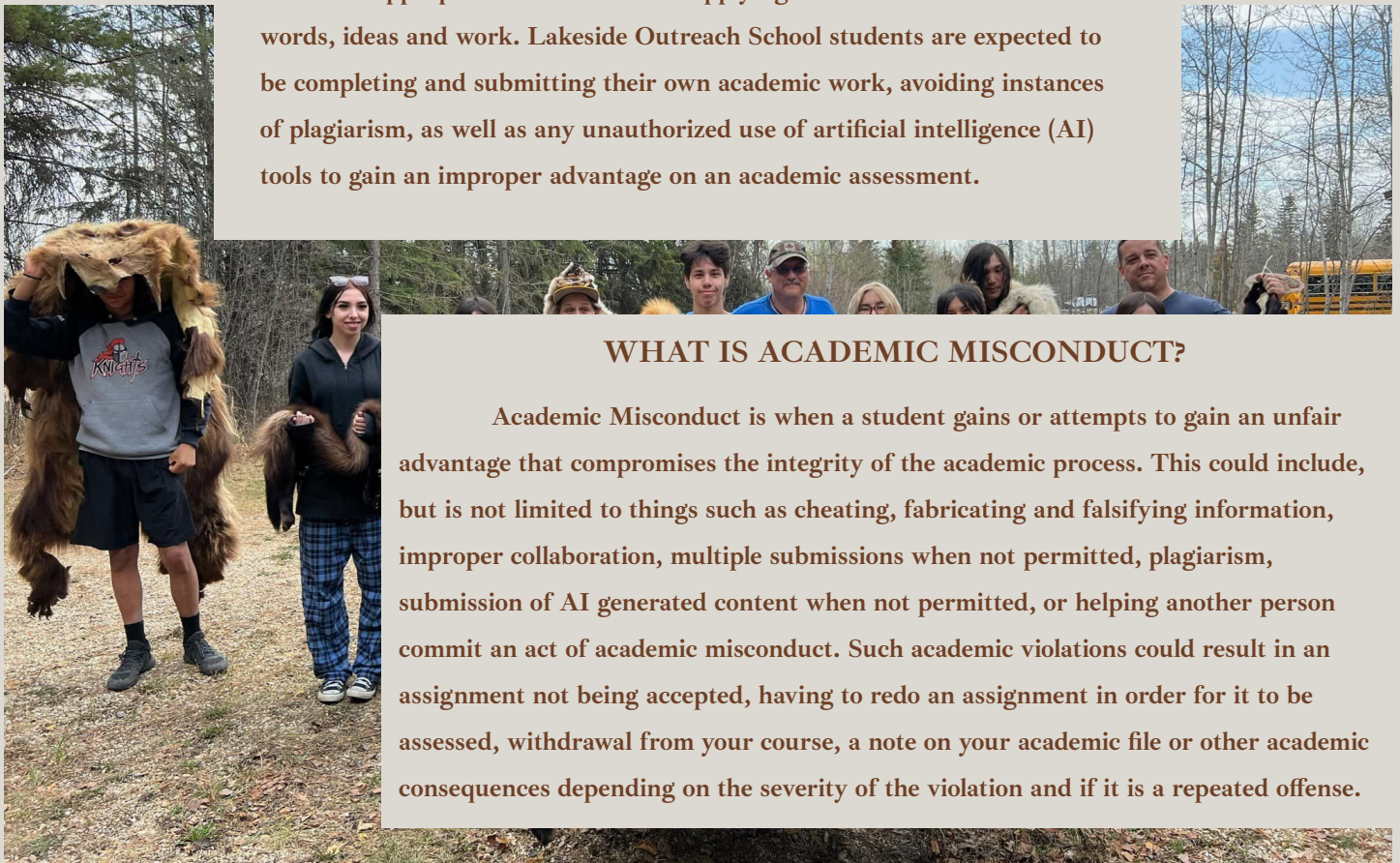

ACADEMIC INTEGRITY



Academic integrity is a “commitment, even in the face of adversity, to six fundamental values: honesty, trust, fairness, respect, responsibility, and courage. From these values flow principles of behaviour that enable academic communities to translate ideals to action” ([International Center for Academic Integrity](#), 2014).

All students are responsible for gaining the skills and knowledge related to appropriate citation and for applying these skills to all borrowed words, ideas and work. Lakeside Outreach School students are expected to be completing and submitting their own academic work, avoiding instances of plagiarism, as well as any unauthorized use of artificial intelligence (AI) tools to gain an improper advantage on an academic assessment.



WHAT IS ACADEMIC MISCONDUCT?

Academic Misconduct is when a student gains or attempts to gain an unfair advantage that compromises the integrity of the academic process. This could include, but is not limited to things such as cheating, fabricating and falsifying information, improper collaboration, multiple submissions when not permitted, plagiarism, submission of AI generated content when not permitted, or helping another person commit an act of academic misconduct. Such academic violations could result in an assignment not being accepted, having to redo an assignment in order for it to be assessed, withdrawal from your course, a note on your academic file or other academic consequences depending on the severity of the violation and if it is a repeated offense.

Career Coach

A career coach is scheduled to be at Lakeside Outreach School one half day per week, available by appointment to provide academic and career counselling; mentoring students on courses, credits, and grades required for high school completion and/or how to apply to post-secondary programs. This coach liaises with organizations and presents information on available post-secondary programs, career opportunities, scholarships, and workshops. All students enrolled in Lakeside Outreach School will be expected to participate in general meetings with the school's career coach as part of the enrollment and academic planning process.

Indigenous Education Coach

An Indigenous education coach is scheduled to be at Lakeside Outreach School one day per week. These coaches collaborate with teachers and administrators to ensure all students deeply understand Canadian history, including Indigenous perspectives, treaties, land agreements, the legacy of residential schools, and contributions of Indigenous culture in shaping our Canadian identity. They also liaise with local Elders and Knowledge Keepers, work to ensure all teachers feel supported in meeting competency five of [Alberta's Teaching Quality Standard](#), and help ensure that students are connected to authentic learning experiences and resources.

Learning Support Teacher (LST)

A learning support teacher is scheduled to be at Lakeside Outreach School one half day per week, and is available to collaborate with administration, teachers, students and families in supporting inclusion at Lakeside Outreach School. Learning support teachers work with staff to develop Instructional Support Plans (ISPs), promote the implementation of universal accommodations, brainstorm modification strategies, provide professional development opportunities, champion literacy and administer or connect families to resources for academic or psychological testing.

Lakeside Outreach School is a community oriented learning environment that seeks to establish a safe, caring, welcoming and respectful atmosphere where all students can be successful. Staff and students enrolled at Lakeside Outreach School have access to a variety of resources to support academic achievement, cultural infusion, wellness and career readiness

Library Program

Lakeside Outreach School has a small in-house selection of books available for study and recreational reading. Full time students can also access library resources from across the school division by contacting our school secretary to request a text. In addition, students' High Prairie School Division credentials provide them access to a variety of ebooks and audiobooks on [SORA](#), the student reading application.

Little Free Lakeside Library

Along the walkway between Lakeside Outreach School and CJ Schurter School you will find the Little Free Lakeside Library, an initiative supported by the school to promote literacy throughout our community. It offers free books to visitors and promotes a "take-a-book, give-a-book" philosophy amongst those that frequent it. You can find it on the official [Little Free Library World Map!](#)

Read & Write For Google Chrome

Using their High Prairie School Division login students have free access to [Read & Write for Google Chrome](#), an extension that includes reading, writing and study tools. Text-to-speech and speech-to-text are two key functions of interest for students using this extension.



STUDENT ENRICHMENT & CHARACTER EDUCATION

Lakeside Outreach School students have many opportunities throughout the year to enrich their learning through various “junior” professional development days, field trips, workshops, guest speakers, alternative assignments, apprenticeships, dual credit courses and personalized timelines for course completion. Students are expected to be leaders and role models when interacting in and with the community, through our established programming. This is discussed and modeled by school staff. In addition, student character and success at school is celebrated on a daily basis, culminating in monthly student recognition awards:

- ★ ‘Citizen of the Month’ is awarded monthly to a Lakeside Outreach School student that positively contributes to a safe, caring, welcoming and respectful learning environment, and demonstrates leadership in the school and community.
- ★ ‘Athlete of the Month’ is awarded monthly to a Lakeside Outreach School student that positively contributes to the school’s Physical Education program and/or the local sporting community and demonstrates good sportsmanship, alongside an understanding that student athletes value academic progress.
- ★ ‘Monthly Masterchef’ is awarded monthly to a Lakeside Outreach School student who shows leadership and responsibility in the kitchen, collaborates well with others, and produces creative and/or well received dishes.



STUDENT ENRICHMENT & CHARACTER EDUCATION

VOLUNTEERISM:

- COMMUNITY VOLUNTEERISM I & II (CCS 1080 & CCS 2080) ARE TWO CTS CREDITS AVAILABLE FOR STUDENTS TO PURSUE AT LAKESIDE OUTREACH SCHOOL, IF THEY CHOOSE. ALONGSIDE A BIT OF COURSEWORK, FIFTEEN VOLUNTEER HOURS PER CREDIT ARE REQUIRED AND SCHOOL STAFF CAN ASSIST STUDENTS IN CONNECTING TO VOLUNTEER OPPORTUNITIES IN THE COMMUNITY THROUGHOUT THE YEAR.

- EACH YEAR LAKESIDE OUTREACH SCHOOL CONTRIBUTES TO COMMUNITY SAFETY BY FACILITATING FIRST AID AND CPR TRAINING FOR A GROUP OF STUDENT LEADERS INTERESTED IN PURSUING THIS VALUABLE SKILL AND EARNING TWO CREDITS.

UNACCEPTABLE BEHAVIORS

- EXAMPLES OF UNACCEPTABLE BEHAVIORS, NOT LIMITED TO:
 - POSSESSION OF OR ACTIVE CONTACT WITH A WEAPON ON A STUDENT'S PERSON, OR IN A PLACE OF THEIR KEEPING
 - THREATS
 - WILLFUL DAMAGE TO SCHOOL PROPERTY OR THE PROPERTY OF OTHERS
 - CONDUCT OR ENCOURAGING CONDUCT, WHICH ENDANGERS ONESELF OR OTHERS
 - USE OR DISPLAY OF IMPROPER, OBSCENE OR ABUSIVE LANGUAGE
 - ACTS OF BULLYING, CYBERBULLYING, HARASSMENT, OR INTIMIDATION
 - THEFT
 - ASSAULT
 - HAZING OR INITIATION ACTIVITIES
 - DISRUPTIVE BEHAVIOR, WILLFUL DISOBEDIENCE, OR DEFIANCE
 - USE, POSSESSION OF, OR DISTRIBUTION OF DRUGS, ALCOHOL, OR INHALANTS IN SCHOOL OR ON SCHOOL PROPERTY
 - INTERFERENCE WITH THE ORDER OF THE SCHOOL DAY
 - TAMPERING WITH SCHOOL SAFETY EQUIPMENT

CONSEQUENCES FOR UNACCEPTABLE BEHAVIORS

- ALL CONSEQUENCES WILL BE MONITORED BY SCHOOL ADMINISTRATORS AND GUIDED BY BEST PRACTICES.
- CONSEQUENCES WILL TAKE INTO ACCOUNT THE NATURE OF THE UNACCEPTABLE BEHAVIOR, THE STUDENT'S AGE, MATURITY, AND INDIVIDUAL CIRCUMSTANCES.
- SUPPORTS WILL BE PROVIDED TO THOSE IMPACTED BY INAPPROPRIATE BEHAVIORS, AND THOSE WHO ENGAGE IN THE ACT(S).
- CONSEQUENCES WILL FOLLOW A PROGRESSIVE DISCIPLINE SCHEDULE AND INCLUDE, BUT NOT BE LIMITED TO: VERBAL REPRIMAND, RESTITUTION, DETENTION, SUSPENSION, RECOMMENDATION FOR EXPULSION, ETC.

ATTENDANCE

Daily attendance will be tracked by the school secretary, based on who attended campus in-person each day. However many students will have part-time and distance learning plans in place that do not require daily attendance and where course progress will be a more important indicator of engagement and success. Lakeside Outreach School students will not receive phone calls home for individual absences. The school will utilize a progressive communication and discipline plan to address attendance and course-completion issues:



Step #1 - If a student has not attended, communicated or submitted coursework within ten school days, the student or parent/guardian will receive a call from a Lakeside Outreach School teacher to discuss student progress and next steps.



Step #2 - If no progress is made or no response received to the phone call home for non-attendance and/or non-completion of coursework within five school days (fifteen days in total without course submissions or communication with the teacher), a follow-up email will be sent by an Outreach teacher to the student and parent/guardian discussing growing concerns about student progress.



Step #3 - If a student has not attended, communicated with the teacher or submitted coursework within twenty school days, the student may be required to commit to an attendance plan or withdraw from the course.

Additional Information On Student Conduct

BULLYING

At Lakeside Outreach School, we define bullying as “repeated and hostile or demeaning behaviour where the behaviour is intended to cause harm, fear, or distress” to one or more individuals in the school community. Bullying comes in three common types; verbal, social (including cyber-bullying), and physical. Bullying adversely affects a student’s ability to learn, healthy relationships and school culture, and the school’s ability to educate its students. Bullying will not be accepted on school property, at school-related activities, or in any other circumstance where engaging in bullying will have a negative impact on Lakeside Outreach School’s learning community.

SMOKING, DRUGS, AND ALCOHOL

Lakeside Outreach School, in cooperation with families, community, and law enforcement agencies, has a responsibility to focus on prevention by educating students about substance abuse problems. Possession, use, or distribution of prohibited or controlled substances is illegal and will not be permitted on school premises or during school activities. We will ensure that students who possess, are under the influence of, or traffic in alcohol and/or drugs while under school supervision receive fair and appropriate consequences.

Smoking and vaping is not permitted on school property. High Prairie School Division has installed vape detectors in all of their junior and senior high schools to address the growing issue of vaping. Students are not to vape on neighbouring private or public property either. Leaving the school property to vape during the school day is not acceptable. Students who are caught vaping will have their vapes and vape products confiscated and disposed of, and will face a one to five day out-of-school suspension, depending on the individual case. As with any incident contravening the school code of conduct, the opportunity to participate in extracurricular activities or attend field trips or excursions may be restricted as well.



Parking

Staff, students and visitors to Lakeside Outreach School may park in the west parking lot, between the CJ Schurter/Lakeside Outreach School property and Slave Lake’s Legacy Centre. Two schools and a daycare are accessed from this parking lot, so drivers should exercise increased caution, and follow all traffic signs and laws.

TECHNOLOGY CONDUCT

Students have access to school-owned devices to complete coursework, while at Lakeside Outreach School. All students must complete a 'Technology User Agreement' before using school-owned devices. Students who violate this agreement may lose access to High Prairie School Division technology. It is a general policy that all technology owned by the school division (including computers, laptops, Chromebooks, iPads, etc.) will be used in a responsible, efficient, ethical, and legal manner. Any behaviour that does not meet this standard can result in the revocation of the user's privileges or other appropriate consequences.

CELL PHONE POLICY

As per the Government of Alberta's '[Ministerial Order 014/2024](#)' and High Prairie School Division's '[Cell Phone Use in Schools Stakeholder Information 2024](#),'

"students are allowed to carry cell phones to school, but they must be turned to silent and stored out of sight during instructional time. It is strongly recommended that students keep their cell phones in their lockers during these times."

Instructional time at Lakeside Outreach School is anytime students are receiving direct instruction from a teacher or attending a scheduled in-person learning experience such as a cooking module, physical education class, academic field trip or guest presentation at the school.

While students who attend Lakeside Outreach School in-person may access their cell phones when working independently, this activity will be monitored by teachers on site and the student could face increased restrictions if appropriate academic progress is not being achieved while attending school.

Teachers and support staff are expected to follow the general guidelines laid forth in High Prairie School Division's 'Cell Phone Use in Schools Stakeholder Information 2024' as well, modeling responsible use of technology to students during the school day. The only time staff cell phone usage is permitted at school is:

- a. when cell phones are being used as an instructional tool and the class, as a whole, is using this tool for educational purposes, or
- b. when the cell phone is required for two-factor verification.

HEALTH & SAFETY

Nutrition

Lakeside Outreach School offers an extensive nutrition and foods program that is both connected to curriculum, and feeding our learning community daily. It is guided by Canada's Food Guide, [Alberta Nutrition Guidelines for Children and Youth](#), and High Prairie School Division's [Administrative Procedure 241 - Nutrition](#), which asserts that "Healthy eating is an integral part of growth and development, and good nutrition is conducive to student learning. Therefore, High Prairie School Division (HPSD) is committed to creating supportive school environments for good nutrition and lifelong well-being by encouraging healthy eating for all students and staff."



Emergency Response Plan

Our first concern, when it comes to an emergency, is the health and safety of students and staff. Our school division has developed an 'Emergency Response Plan' intended to address emergency situations that may occur at school. School disaster plans have been designed to deal with situations such as natural disasters, severe weather conditions, fires, violent behaviour and criminal acts. For more specific information, please refer to High Prairie School Division's [Administrative Procedure 178](#). Throughout the school year, Lakeside Outreach School will practice and discuss emergency response drills such as fire drills, lockdowns etc. These drills help all students and staff in the building prepare to respond in case of emergency.

Responding To Threats Of Violence

All threats against people and/or facilities shall be taken seriously. The purpose of threat assessment is to determine whether a person poses a threat, not to determine if a person made a threat. When investigating and responding to a threat to commit violence, schools will use the Comprehensive School Threat Assessment Guidelines (CSTAG). CSTAG is a problem-solving approach to violence prevention that involves both assessment and intervention with individuals who have threatened violence toward others. Following the CSTAG assessment, other administrative procedures dealing with the safety of the school and student discipline may apply. High Prairie School Division's [Administrative Procedure 343](#) contains more specific information about this process.

Emergency School Closure

Please note that it would be extremely rare for a school to close, even in cold/severe weather. Lakeside Outreach School will remain open between 8:30am-3:30pm, even when buses are canceled due to severe weather and road conditions. High Prairie School Division's [Administrative Procedure 130](#) states that "the Superintendent or the Safety Officer shall close a school and dismiss students and/or employees from attendance if closure is ordered by an appropriate officer of the provincial government, or the health and/or safety of students or employees is endangered."

Building Safety & Security

Lakeside Outreach School is a secure building that remains locked at all times. The first set of doors, at the front, is unlocked from 8:30am-4:00pm daily, allowing visitors to enter and sign-in, before staff provides access to the office and main classroom area.

Students

Students who attend Lakeside Outreach School in-person will enter through the front doors, upon arrival, and sign in to the designated logbook that is accessible inside of the entrance. They will then be provided access to the locked building. Students are also asked to sign out of the building when they leave at breaks, lunch or for the day.

Visitors

Parents/Guardians and other visitors to Lakeside Outreach School, who wish to meet with a staff member, should call and speak with the secretary to determine availability and schedule call backs or in-person meetings at the school. Visitors to the school will enter through the front doors, upon arrival, and sign in to the designated logbook that is accessible inside of the entrance. They will then be provided access to the locked building and will be directed by the secretary. Visitors are asked to sign out of the building when they leave for the day.
